As other cities across the United States confront rising homelessness, Chicago experienced a 28% reduction in the number of people experiencing homelessness from 2020 to 2022. During that time, Renaissance was a lead partner in implementing bold new initiatives like the Expedited Housing Initiative and Flexible Housing Pool, which have helped more than 3,000 Chicagoans move from the streets and shelters to permanent housing.



**People experience housing instability and homelessness** across a broad spectrum. Renaissance offers innovative and effective solutions to people across this spectrum - from individuals and families experiencing brief, situational episodes of homelessness needing short-term assistance to regain stability, to people with significant mental and physical health issues experiencing long-term, chronic homelessness needing permanent supportive housing and ongoing services.

## **Solutions to Homelessness**

**Our Approach** 

**Homelessness Prevention:** Renaissance prevents homelessness in Chicago by providing short-term emergency funds to people at risk of losing their homes. The agency provides payment directly to the source for urgent financial hardships, such as car repairs or unexpected medical bills, which could result in missed rent payments and eviction. Additional referrals and support services are provided to link households to stabilizing resources in the community.

### **Flexible Housing Pool Outreach & Case**

**Management:** As a key partner in Chicago's Flexible Housing Pool (FHP), Renaissance conducts outreach to homeless individuals and families targeted for housing by the FHP. The program locates and engages homeless people who have been identified as high utilizers of the health care system and engages them into support services, housing, and primary and preventative health care.



Homeless Street Outreach: Street outreach teams visit shelters and encampments on a regular basis to engage with people; provide food, clothing, and personal supplies; offer transportation to health care; and build relationships. Over time, growing trust allows team members to move people into housing and help them engage in mental health and primary care services.

**Rapid Re-Housing:** For individuals and families who do not need intensive and long-term supports to exit homelessness and maintain permanent housing, Renaissance provides short-term housing assistance and case management that focuses on building individuals' income and strengths so that they can quickly return to housing independence and stability.

**Diversion Housing:** Renaissance provides temporary housing for individuals with serious mental health issues awaiting placement into permanent housing. Temporary housing is more stable than shelter or hospitalization and can improve individuals' health outcomes.



**Permanent Supportive Housing:** In partnership with landlords across Chicago, Renaissance operates site-based and scattered-site permanent supportive housing programs, offering rent subsidies and wraparound supportive services to help participants increase their stability and autonomy. Renaissance maintains ongoing relationships with participants to ensure they can stay in their homes.

- Seniors Program site-based and scattered-site permanent supportive housing for older adults


**Behavioral Health Services:** To help participants move towards the greatest degree of stability possible, Renaissance provides critical mental health and substance use recovery services.

- **Community Support Services** provides clinical mental health services for people with mental health diagnoses in the community. Clinical case managers meet with program participants in their homes to help them understand and address behavioral health symptoms that are creating impediments or causing instability in their lives.
- Hospital Engagement Pilot Program (formerly called The Living Room), located in the Austin community on Chicago's West Side, supports homeless adults following their discharge from nearby safety-net hospitals. Specially trained team members provide recovery support services, housing placement assistance, and connection to resources in a safe, inviting, and home-like atmosphere.

## **Transformational Outcomes**

2,171 households received resources to prevent becoming homeless.

545 participants lived in the agency's permanent supportive housing, including 57 families.



### KEY MOMENTS 1997-2023

## 1997

Renaissance started with one case manager and one part-time director, providing supportive services to residents in one building. By 2022, Renaissance served more than 3,800 people – individuals and families – in multiple buildings and hundreds of scattered-site apartments, with a diverse team of 59 employees.

## 2007

Renaissance created the Chronic Homeless Initiative, the first of its kind in Chicago. This initiative helped chronically homeless individuals, who were historically underserved in permanent supportive housing, move into a beautifully renovated building in Wicker Park using a housing-first perspective and provided them with supportive services to help them attain stability and increase their self-determination.

## 2010

Renaissance received notification that it was one of seven recipients in the United States to receive a five-year Services in Supportive Housing grant from the federal Substance Abuse and Mental Health Services Administration. The Supportive Housing Outreach Team was created to serve Chicagoans who had been homeless the longest and who had the most severe disabilities. 630

people living on the streets and in shelters were connected to housing, health care, and other needed services.

### 86% of housed participants received communitybased integrated health care.

## 2017

Renaissance launched the Family Support Program – a new program to provide supportive housing for 45 chronically homeless families. The Family Support Program's primary funding is a \$1.4 million annual grant from the US Department of Housing and Urban Development.



The Cost of Homelessness

The personal trauma and social cost of homelessness are great. Research published by the National Health Care for the Homeless Council found that without stable housing, unhoused people cycle in and out of emergency departments, inpatient hospital stays, psychiatric centers, detoxification programs, and jails, resulting in high public costs and poor health outcomes for individuals including premature death.

With support from Renaissance's dedicated and compassionate team members, participants achieved significant personal outcomes in 2022:

### 2018

Renaissance became a State of Illinois-certified Community Mental Health Center and in 2021 became accredited by CARF International for the delivery of mental health services to children and adults.

## 2019

Renaissance became a lead partner in Chicago's Flexible Housing Pool, a coordinated effort to provide permanent housing and wraparound services to the most vulnerable Chicagoans experiencing homelessness. To date, more than 1,200 people have been housed, resulting in a 33% reduction in inpatient hospitalization days.

### 2020

Renaissance opened a peer-led mental health crisis drop-in center in the Austin community called The Renaissance Living Room, which brought much needed access to quality mental health services in a community lacking access to such care.
